#### MISSION:

Trait d'Union USA-Mauritius is organized exclusively for charitable purposes. Its main objective is to provide needy Mauritian children, of any ethnic diversity or background, with the opportunity to achieve a better quality of life through education, healthcare and nutrition. The services are provided by staff members of the IMF and World Bank who are all volunteers and share the common goal of helping the poor children escape a life of poverty.

TUUM has helped Saint Pierre RCA School - St Pierre, Saint Esprit RCA School - Eau Coulee, Queen Victoria RCA School - Flacq, Notre Dame des Anges RCA - Mahebourg, Notre Dame de la Confiance - Curepipe, Olivia RCA School - Olivia, Saint Antoine RCA - Goodlands, in their renovations, the replenishing of their book supplies, replacing the roof, and an asphalted yard.
